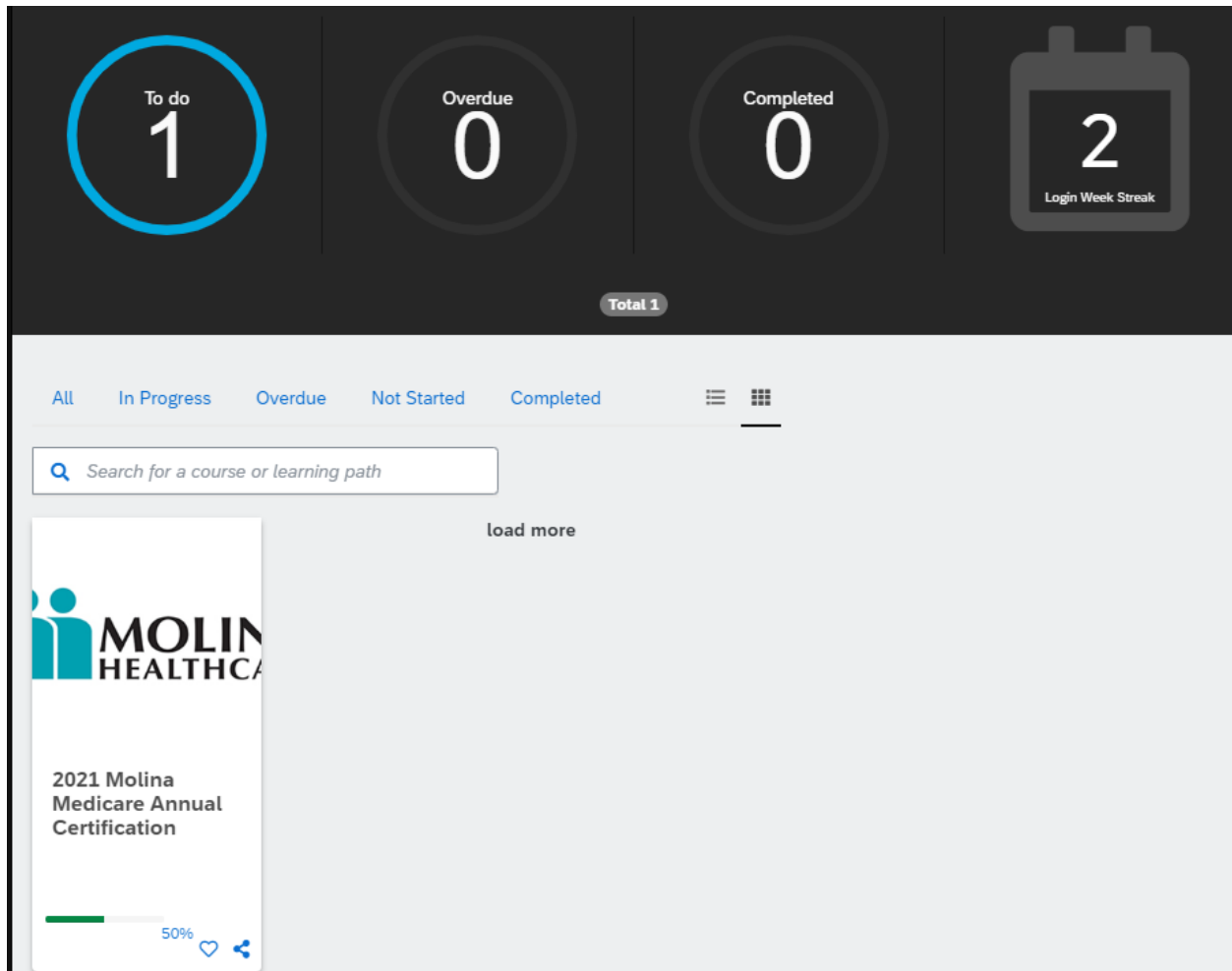

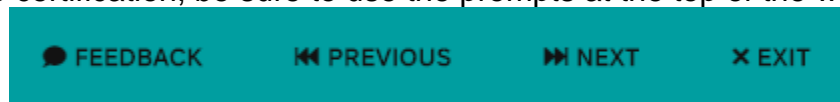

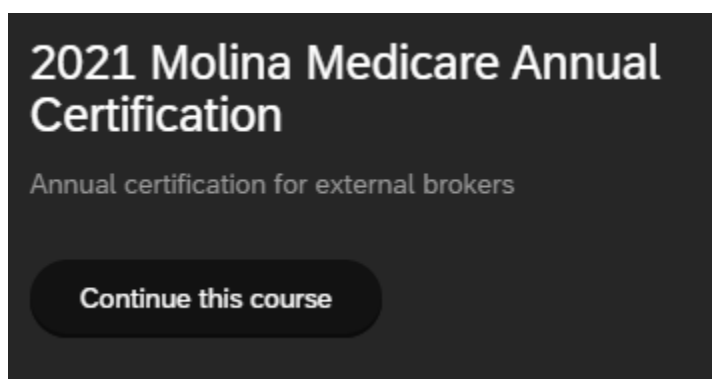
Be sure to turn on the sound so you can hear what each slide is discussing. If needed, you can use the closed captioning within the slide.



During the product training and quiz, please use the prompts within the slides to ensure completion of each section.



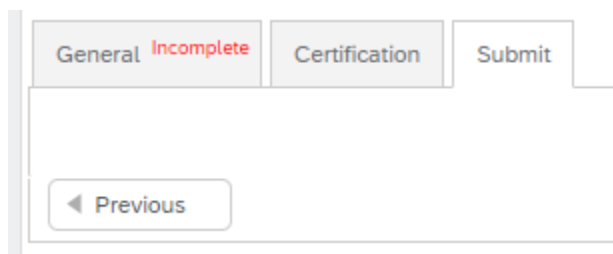
If the course brings you back to your certification modules, you can easily click on Continue this course at the top of your certification module.
